In 1973 after thirty-four years Pap retired from the store business to take care of Veronica who was seriously ill. Sadly she passed away that year. Pap continued to sell insurance and in 1976 met a young lady named Beatrice Briand from L'Ardoise and she

has been his wife for the last twenty-six years. Beatrice has a son Lawrence and two granddaughters from her previous marriage. Ten years later at the age of seventy-one, and thirty-two years in the insurance business Pap retired.

Wintering In River Bourgeois

During the course of our stay here each year, my wife Marj and I are often asked why we choose to spend winter in River Bourgeois rather than the summer, as is the custom with many retirees.

There are a number of reasons for our choice. First, our children (6) and our grandchildren (12, soon to be 13) live either in Western Canada or in Nova Scotia. Second, Marj's relatives all live in Alberta, which is close to our summer home, while

most of my relatives, are here in River Bourgeois. Third, Marj's health eliminates Florida as an option, although that wasn't a priority anyway.

But why winter in Cape Breton and not in Western Canada. The answer, simply, is: the milder weather. For us, the coldest winter day here is no hardship, as it translates to a normal winter's day in Alberta or Saskatchewan. Let me give you three illustrations of what I mean.

In 1968, while I was in Graduate Studies in Edmonton, we experienced 32 consecutive days when the temperature did not once rise above -17.8C (the old zero of Fahrenheit days). Waiting for the bus to go to and from classes each morning and evening temperatures that were usually in the -40C range was somewhat of a torture, I can assure you.

One morning in 1978 I got an early telephone call from the principal of our St. Jerome's School in Vermilion, Alberta. The temperature at the Vermilion Airport had just been announced at -55F. In 26 years as a superintendent, that was one of the few times I ordered the schools to be shut down because of weather or road conditions.

But our decision was finalized during our last winter in Saskatchewan. In the winter of 1993-1994, the cold weather set in the Saskatoon area in mid-October and did not lift until the last week of March. December, January, and February were the coldest on record, with AVERAGE temperatures being about -22C. We saw the plus side of Zero only five times in a stretch of 165 days; and since Marj's asthma is aggravated by extreme cold, the decision to winter in Cape Breton was not difficult.

I must mention that there are some down sides to Cape Breton winters. Icy roads and poor visibility are far more frequent here than in our Western provinces; the high winds and recurring snow and rain are not pleasant; and the quick changes in weather certainly make winter travel more hazardous. But the pluses far outweigh the negatives: the much milder temperatures, the beautiful fall months, the far shorter winters, the glistening snow in the fields and on the trees, and the moonlight shining over the calm harbour – each of these is enough to keep us here for many winters to come, God and our budget willing. *Stan Digout*

The purpose of this book is to record the history of the Society, its work and members and to pay tribute in print to its activities and accomplishments as well as say thanks to all those who helped. It's an ambitious project that will involve many volunteers.

RBCSS Annual Meeting 2002

The 24th Annual Meeting of the RBCSS was held at the Tara Lynne Community Center (TLC) on Wednesday, March 20, at 7:00 p.m. Reports were received from Committee chairpersons on the operations of the Society over the past year.

President Wayne Bona documented the initiatives developed in 2001, which included the complex sign on Route #4, removal of old and installation of new playground equipment, the development of the Society Web page which can be viewed at http://www3.ns.sympatico.ca/rbcap/riverbourgeois/hall.htm, the establishment of the Youth Development Committee and the bringing of the Parent & Tot Program to the TLC.

The 2001 financial Statement for the Society reported income from the Bingo of \$248,480 and expenses of \$208,669 including prizes of \$169,940 that went back to patrons of the bingo and \$10,764 to the Jackpot and Cookie Jar. Revenue from a special card at the Bingo, donated \$6,093 to St. John the Baptist Church. \$289,077 in revenues were generated from all activities; \$248,480.00 from Bingo and \$40,597.38 from other fund raising activities. The Funeral Home had expenses of \$3,263 and revenues of \$712. This home provides a muchappreciated service to the community. Total expenses were \$265.932 including the bingo,

maintenance and activity costs. Net profits were \$23,145.

The Society has total current assets of \$54,557, total fixed assets of \$503,217. Accounts payable of \$3,348 and Credit Union Mortgage Balance of \$30,264 make up liabilities of 30,264. More information is available in the Income Statement & Balance Sheet available in the community.

Based on the financial report the Bingo Committee and all its workers did a tremendous job of raising funds for the RBCSS. The committee also reported on changes with the bingo over the year as well as the need for new workers. Anyone willing to help out, please call Joan Burke at 2557.

The Technology & Training Center had an excellent year with revenues of \$18,048.01 and expenses of \$14,396.85. Volunteers during the year staffed the CAP site with 1670 hours of free time enabling it to be open 25 hours a week during fall, winter and spring. The River Round Up is a popular newsletter published through the CAP site and is welcomed both in the community and afar bringing local news and bits of history to readers. 4 RB students were employed in the summer, which enabled the CAP site to be staffed fulltime during the They assisted in the digitalization of festival projects, RBCCS records and the old River They, along with volunteers also Round Ups. provided activities for Canada Day.

The Economic Development Committee was quiet for most of the year but was responsible for the Complex Sign along Route #4 Highway and they continue to work on the Lighthouse Rebuilding Project.

The Festival Committee executed the 23rd Annual River Bourgeois Festival with a combination of some old and new events. The festival gross revenues were \$14,238 with expenses of \$5,788 for a profit of \$8,450, a tidy sum for a small community on a weekend series of events.

The Youth Development Committee began in September and carried out events such as a turkey pie sale that raised \$1000 and a luncheon and Flea Market that cleared \$780. The committee restored teen dances to the hall with no problems encountered, (security is on hand). They held 4 teen dances, 3 preteen dances: pay teens to operate the Music Machine, which they have purchased and used it at the New Years Dance. The recent March Break Party was a huge success with over 65 children attending.

Once again we are looking for people to count birds in Richmond Co. on May11th as part of the North American Migratory Count. You can do it at your feeders or we can assign you an area to go searching. Last year we had 27 participants who recorded 72 species. This is the 7th year that Richmond Co. will be participating.
